

8. PROFICIENCY: NONE


Class proficiency on the 1st degree will be held on June 17, 2025, at 7:30 pm.





To the Esteemed Brothers of Pikes Peak Lodge No. 5

Greetings Brethren,

We come to you not just as your Brothers, but as the Trustee Committee of Pikes Peak Lodge No. 5—a collective that genuinely believes in the legacy of our Lodge. We're closing in on 150 years—an accomplishment few can claim. But with that legacy comes a harsh reality: our building is falling apart, and ignoring it any longer is simply not an option.


Our lodge, built over a century ago, has seen the test of time—but the years have not been kind. The cracks aren't just physical; they're symbolic of neglect we can no longer afford. We're not alone in this. Countless organizations are fighting for preservation dollars, and the competition is fierce. Grants and nonprofit funding are drying up, and we can't sit around waiting for a miracle.

Here's the truth: our Endowment Fund sits at less than \$500. That's it. And that's not even close to what's needed to make the critical repairs required to keep our doors open and secure our financial future.

After careful discussion, the decision was made to propose a one-time member assessment of \$1,500, spread over five years—\$300 a year. We know it's not a small ask. We know dues were just raised. But we are asking you to see this not as another bill—but as an investment. An investment in our legacy, in our future, and in the continued strength of Pikes Peak Lodge No. 5. An investment that goes beyond just building repairs, but also strengthens our savings and investments for years to come.

Understand this: this building doesn't belong to any one of us—it belongs to all of us. Every Brother who's walked through those doors shares in the responsibility of keeping it standing. This isn't about dues—it's about survival. Without these repairs and financial stability, we're looking at some hard decisions, including the possibility of selling our building. We don't want that, and we know you don't either.

We're not sitting idle. We're pursuing grants, donations, and community partnerships—but those things take time, and time is not on our side. Fundraising isn't as reliable as it used to be, and competition for nonprofit dollars is fierce.



We also want to be clear: this Endowment Fund Assessment will apply to all new members raised, demitted, or reinstated into Pikes Peak Lodge No. 5, ensuring that every Brother who joins shares in the commitment to our legacy and financial future.

Additionally, any Brother who has been assessed and is suspended for non-payment must fulfill their Endowment Fund obligation in full before reinstatement. This ensures fairness and accountability for all members contributing to this critical initiative.

Think about what this Lodge has meant to you: the memories, the Brotherhood, the lessons learned. Now think about what it would mean to lose it. Without action, that's exactly where we're headed.

It's time to step up. Not just in words, but in action. Let's preserve our Masonic home—not just for us, but for the Brothers who come after us.

TO: Most Worshipful Master, Past Masters, Officers, and Brethren of Pikes Peak Lodge No. 5

SUBJECT: Resolution to Amend Article IX – Dues & Fees of the Lodge Bylaws

WHEREAS, Pikes Peak Lodge No. 5 recognizes the historical significance and legacy of our Lodge as we approach the 150th Anniversary in 2028; and

WHEREAS, our Lodge building, constructed over a century ago, requires substantial repairs and restoration to maintain its structural integrity and continue serving as the cornerstone of our Masonic journey; and

WHEREAS, the current Building Fund balance of less than \$1500.00 is insufficient to address the critical repairs needed, and relying solely on grants and nonprofit funding is not feasible given the competitive landscape for preservation dollars; and

WHEREAS, the financial stability and preservation of our Lodge building are paramount to ensuring its legacy endures for future generations of Brothers;

THEREFORE, BE IT RESOLVED, that Article IX – Dues & Fees of the Pikes Peak Lodge No. 5 Bylaws be amended to include the following:

SECTION 9.04 BUILDING FUND ASSESSMENT

9.04.01 Building Fund Assessment: To secure the necessary funds for critical building repairs, savings, and investments, a one-time assessment of \$1,500.00 shall be levied on each member of Pikes Peak Lodge No. 5, payable over a five-year period (\$300.00 per year).

9.04.02 Payment Options: Members may fulfill the assessment in the following manners:

- One-time payment of \$1,500.00;
- Annual payment of \$300.00, due by December 31st of each year;
- Quarterly payments of \$75.00; or
- Monthly payments of \$25.00.



9.04.03 Delinquency Policy: Members who do not meet the annual \$300.00 obligation by the December 31st deadline shall be classified as delinquent, subject to the same penalties and notifications outlined in Section 9.01 of the Bylaws.

9.04.04 Transparency and Tracking: Payments towards the Building Fund Assessment shall be tracked and recorded separately from regular dues to ensure clarity and accountability. Members will have access to their individual balances and may request status updates at any time from the Lodge Secretary.

9.04.05 Exemptions: The assessment shall not apply to:

- Dual members with Pikes Peak Lodge being their secondary Lodge
- Lodge Life Members
- Grand Lodge Life Members
- Members granted financial waiver status under Section 9.02 of the Bylaws

9.04.06 New Member and Reinstatement Assessment: All members newly raised or demitting into Pikes Peak Lodge No. 5, as well as those seeking reinstatement, shall be subject to the same Endowment Fund Assessment with the same 5-year timescale and payment options as existing members.

9.04.07 Reinstatement Requirement: Any member who was assessed and subsequently suspended must repay the remaining balance of the Endowment Fund Assessment in full before being reinstated into Pikes Peak Lodge No. 5.

BE IT FURTHER RESOLVED, that this amendment to Article IX – Dues & Fees shall take effect immediately upon approval by the Craft and all Grand Lodge Requirements with the first assessment payment due by December 31, 2025.

We trust that all members will recognize the importance of this assessment in preserving the legacy of Pikes Peak Lodge No. 5, ensuring that our Masonic home remains strong and enduring for future generations.

Masonry's Twelve Original Points

Ancient Masons used the "Twelve Original Points" in the form of allusion & symbolism, thus aligning them with the Twelve Tribes of Israel. Finding such symbols in a distant time lends unquestionable antiquity to our Order. The twelve points are as follows:

- 1. <u>The Opening of the Lodge</u> symbolizes the tribe of Reuben, as Reuben was the first born of his father Jacob, who called him, "the beginning of his strength." He has therefore been adopted as the emblem of that ceremony, which is essentially the beginning of every initiation.
- **2.** The Preparation of the Candidates/Brothers symbolizes the tribe of Simeon, because Simeon prepared the instrument for the slaughter of the Schechemites & that portion of the ceremonies which related to offensive weapons was used as a token of our hatred for the cruelty exercised on those occasions.
- **3.** The Report of the Senior Deacon symbolizes the tribe of Levi, because in the slaughter of the Schechemites, Levi is said to have made a signal or report to Simeon with whom he was engaged in attacking these unhappy people while they were unprepared for defense.
- **4.** The Entrance of the Candidate/Brother into the Lodge symbolizes the tribe of Judah, because they were the first to cross into the river Jordan & enter the "Promise Land", thus coming from servitude & darkness of the wilderness, into the liberty & light in Canaan.
- **5.** <u>The Prayer</u> symbolizes the tribe of Zedulun because the blessings & prayers of Jacob was given to Zedulun in reference to his brother Issachar.
- **6.** <u>The Circumambulation</u> refers to the tribe of Issachar, because as a thriftless & indolent tribe, they needed a guide to lead them to an equal level with the other tribes.
- **7.** Advancing to the Altar Symbolizes the tribe of Dan, to teach us by contrast, that we should advance to truth & holiness as rapidly as that tribe advanced to idolatry. This tribe was the first to set up a serpent to receive adoration.
- **8.** <u>The Obligation</u> symbolizes the tribe of Gad through the allusion of the solemn vow made by Jephthah, judge in Israel who was of that tribe.
- **9.** The Entrusting of the Candidates/Brothers with the Mysteries symbolizes the tribe of Asher, as he was presented with the rich fruits of Masonic knowledge, as Asher was said to be the inheritor of fatness & royal dainties.
- 10. The Investiture of the Lambskin Apron by which the candidate is declared free, symbolizes the tribe of Naphtali which was invested by Moses with a peculiar freedom


- when he said, "Oh Napthali, satisfied with favor & full of the blessing of the Lord, possess thou the West & the South."
- **11.** The Ceremony of the Northeast Corner of the Lodge is an allusion to the Joseph, because this ceremony reminds us of the most superficial part of Masonry, so the two half tribes of Ephraim & Manasseh of which the tribe of Joseph was composed. They were accounted to be more superficial than the rest, as they were descendants of the grandsons of Jacob.
- **12.** <u>The Closing of the Lodge</u> symbolizes the tribe of Benjamin, who was the youngest of the son of Jacob & thus, closed his father's strength.

These Twelve Points from Ancient English Masonic literature are examples of Freemasonry's inclusions of bibliography & antiquity. It also demonstrates an example of the differences in basic studies to be found across the globe. In certain regions/countries where they have state religions or do not recognize Judaism or Christianity, differences are even more profound. Despite said differences, the intent of the Craft is the same across all religious grounds.




