Subject: Financial Committee Proposed Lifetime Dues

Worshipful Master, Past Masters, Wardens, and Brothers,

To establish a financially sustainable Lifetime Dues Program that encourages long-term commitment while providing the Lodge with immediate capital for reinvestment. This proposal updates our previous approach by using a tenure-based structure, a variable markup scale, and a 2-year installment option for newer members.

Assumptions:

- Annual Lodge dues: \$191
- Inflation rate: 3% per year on average
- Investment return: 7% per year (Conservative Assumption)
- Lifetime dues are calculated over 50 years of total service
- Tiered pricing model includes variable markups based on years of service

Proposed Lifetime Dues by Tenure Tier

Years of Service	Estimated Years	NPV of Growing Dues	What They'd Pay Over Time	Markup %	Recommended Lifetime Fee
1 (0-5 years)	50	\$4,064	\$22,191	+50%	\$6,096
2 (5-15 years)	40	\$3,735	\$14,834	+40%	\$5,229
3 (15-25 years)	30	\$3,252	\$9,360	+20%	\$3,903
4 (25-35 years)	20	\$2,115	\$5,286	+10%	\$2,327
5 (35+ years)	10	\$1,247	\$2,255	0%	\$1,247

Justification for Tiered Model:

- Higher markups for early-tenure Brothers reflect their longer expected engagement and need to mitigate potential risk over tenure.
- Modest pricing for senior Brothers recognizes their long-term service and reduces financial burden in later years.
- This structure helps fund the Lodge's financial obligations while ensuring fairness across service levels.



To encourage affordability, members in the 0-5- and 5-15-year category may opt to pay 50% of the Lifetime Fee in Year 1 and the remaining 50% in Year 2. **No refunds will be issued once the first installment is paid.**

Tiers 4 & 5 will enroll on a first-come, first-serve basis and will only be admitted after commitments from Tier 1 (1:2) and Tier 2 (1:1).

Sustainability and Forecast:

The Lifetime Dues Program is designed to balance affordability for members with long-term financial resilience for the Lodge.

Dues have been priced based on a **conservative 7% investment return**, which provides a prudent foundation for maintaining adequate reserves. However, internal financial modeling also considered a **15% annual return** scenario, achievable through pooled investments, ETFs, or other vehicles already approved by the Lodge.

To demonstrate feasibility, the Financial Committee modeled a scenario with **8 members enrolled across tenure tiers**, including the 2-year installment option for new members:

- **Total collected:** \$29,181
- **Total dues liability (NPV):** \$22,647

With proceeds invested at 15%:

- After **5 years**, the fund would grow to **\$36,668**, yielding a **149.6% return** on obligation
- After **10 years**, the fund would reach **\$113,686**, with a **+402.0% return** and **\$91,039 in margin**

These results confirm the program's sustainability, even after satisfying all future dues obligations. The model assumes disciplined investment, limited refund exposure, and continued oversight by the Financial Committee.

Voluntary Participation:

This program is entirely optional. Members who wish to continue annual payments may do so. Lifetime payments are non-refundable and non-transferable.



For participants who choose to sign up, a \$250 commitment fee will be submitted with the sign-on form. This fee will be applied toward commitment dues if the commitment is fulfilled within 12 months.

If the 12-month window expires due to circumstances beyond the participant's control (e.g., illness, relocation), the committee may, at its discretion, approve reallocation of the fee toward the following year's dues or refund the balance.

Eligibility:

All members in good standing may apply to enroll. The installment option applies only to members in the 0–5-year and 5–15-year categories.

Approval Mechanism:

All lifetime dues payments must be reviewed and approved by the Secretary, Treasurer, and Financial Committee Chair. Members must be informed that dues are non-refundable once initiated.
